4.0 EARNEST MONEY DEPOSIT

5.0 SUBMISSION OF BID DOCUMENT

The bidders are required to submit their bids in three separate envelopes marked as 'A, B & C'.

- a. Envelope 'A' must contain TENDER DOCUMENT COST & EMD in form of fixed deposit. Demand drafts of Rs. 5900/- inclusive of GST as applicable, as cost of tender document and Rs. 1,50,000/- as earnest money deposit should be submitted in Envelope 'A'.
- b. Envelope 'B' must contain Technical Bid and concept plan as required
- c. Envelope 'C' must contain only Financial Offer in prescribed format. Financial offer shall include the total cost i.e., permission charges, local taxes, toll, labour, material, transport and dismantling etc. excluding GST only.

6.0 SUBMISSION AND OPENING OF BIDS

Sealed bids in three separate envelopes as described in Para 3.0 above can be submitted up to 3.00 PM on 28.10.2025 only at the head office of CSIDC i.e. 1st Floor, Udyog Bhawan, Ring Road No.1, Telibandha, Raipur – 492 006. Bids shall be opened at 4.00 PM on 28.10.2025 at the same venue.

- a. Envelope-A shall be opened first and examined.
- b. Envelope-B shall be opened of only those bidders who have submitted the required EMD– cum Bid Security and cost of tender document.
- c. Envelope 'C' shall be opened only of the bidder with highest score in technical evaluation and presentation round. Date of opening of Envelope-C shall be intimated separately to qualified bidders so that they may be present if they so desire.

The financial offer shall be opened only of the highest scorer in technical evaluation and presentation round on decided date at office of CSIDC, 1st floor Udyog Bhawan, Ring Road No.1 Telibandha, Raipur – 492 006 (C.G).

The Financial offers (Envelope-C) of technically not qualified bidders shall be returned unopened.

The bidders are required to submit in Envelope-B detailed concept designs incorporating requirements as per the theme "EK Bharat, Shreshtha Bharat" and keeping in mind the introduction part of this document along with documents required for qualification. The offers should have the provision for all required work to be carried out for fore-ground development and interior decoration. Bidders are required to give respective quantities and the unit rates of listed items according to their concept and design in their turnkey offers in the enclosed format. (Annexure-I).

The short-listed participants shall be required to make a visual presentation of their concept design at their own cost before Tender Committee in the office CSIDC at Raipur (C.G.).

7.0 EVALUATION OF BIDS

The evaluation and recommendation of the bids shall be done by the Selection Committee. Final selection of the bidder shall be done by Managing Director whose decision would be final and binding upon all participating bidders and no claim or arbitration would be entertained at later date.

The evaluation of the bids submitted by the Bidders would be on the following criteria.

All the Bidder's, whose bids are found to be technically qualified as per Tender, shall be called for Creative Presentation. The Bidders are required to make a presentation showcasing the ability of the agency for successfully carrying out the Event. A Scrutiny Committee constituted by the Authority shall scrutinize the Creative presentations made by the Bidders as per the parameters. Final selection of the Bidder shall be done by the Managing Director (CSIDC), whose decision would be final and binding upon all participating Bidders and no claim or arbitration would be entertained at a later date.

Proposal Evaluation Parameter:

The Applicants fulfilling the Minimum Eligibility Criteria will be eligible for further evaluation process. The Applicant's competency and capability shall be evaluated on the basis the following two stage process:

Stage 1: Technical Evaluation

This stage is divided in two sections:

- Financial Capability
- Technical Capability

At the end of this stage, each Bidder will have a technical score (out of 100). The Bidder's will be shortlisted based on the minimum score 65 or above.

Highest scorer (TM) of the Technical Proposal Evaluation round will be given a technical score (ST) of 100 points.

The technical scores of other proposals will be computed as follows:

ST = 100 x T/TM (T = Technical Score of the applicant)

Stage 3: Financial Evaluation

Financial Proposal Evaluation Parameter:

The financial bid will be opened only of the shortlisted bidders who score 65 marks and above.

In this stage, the financial evaluation will be carried out. The cost indicated in the Financial Proposal should be deemed as final and reflect the total cost of services. Omissions, if any, in costing any item shall not entitle the Applicant to be compensated and the liability to fulfill its obligations as per the Terms & Conditions within the total quoted price shall be that of the Applicant. The lowest Financial Proposal (FM) will be given a financial score (SF) of 100 points. The financial scores of other proposals will be computed as follows:

 $SF = 100 \times FM/F$

(F=Amount of Financial Proposal) Combined and Final Evaluation:

Proposals will finally be ranked according to their combined technical (ST) and financial (SF) scores as follows:

S= ST x Tw + SF X Fw

Where, Tw and Fw are weights assigned to Technical Proposal and Financial Proposal that shall be 0.80 and 0.20 respectively.

The Selected Applicant shall be the Applicant having the highest combined score. The second highest Applicant shall be kept in reserve and may be invited in its discretion for negotiations in case the first-ranked Applicant withdraws or fails to comply with the requirements as per the TENDER DOCUMENT.

8.0 SUGGESTIVE POINTS FOR DEVELOPING THE CONCEPT PLAN

- 8.1 Thoughtfulness and clarity in depiction of the theme and realizing features of the concept including provision of sufficient and proper digital display, Live Demo, and sale counter (modern stalls) within the pavilion.
- 8.2 Incorporating sustainable materials into the design of the Chhattisgarh Pavilion at IITF 2025 can significantly enhance its environmental friendliness and appeal. Here are some strategies to achieve this:

A. Use of Eco-Friendly Materials

Bamboo and Cane: Utilize bamboo and cane for structural elements, furniture, and decorative items. These materials are renewable, biodegradable, and have a low carbon footprint.

Recycled Wood: Incorporate recycled or reclaimed wood for flooring, paneling, and furniture. This reduces the demand for new timber and promotes the reuse of existing resources.

Natural Fibers: Use natural fibers like jute, coir, and cotton for textiles, upholstery, and decorative elements. These materials are biodegradable and have minimal environmental impact.

B. Sustainable Construction Techniques

Modular Design: Opt for modular construction techniques that allow for easy assembly and disassembly. This reduces waste and enables the reuse of materials in future projects.

Green Walls and Roofs: Incorporate green walls and roofs to improve insulation, reduce heat island effects, and enhance the aesthetic appeal of the pavilion.

E. Waste Reduction and Management

Recycling Stations: Set up recycling stations throughout the pavilion to encourage visitors to dispose of waste responsibly.

Compostable Materials: Use compostable materials for disposable items such as plates, cups, and cutlery in any food service area.

F. Minimal Packaging:

Reduce packaging for promotional materials and products, opting for recyclable or biodegradable options when necessary.

G. Promoting Local Artisans and Sustainable Practices

Artisan Crafts: Highlight the work of local artisans who use sustainable materials and practices. This not only supports the local economy but also promotes environmentally friendly craftsmanship.

Educational Displays: Include educational displays that inform visitors about the sustainable materials and practices used in the pavilion's construction and operation.

- 8.3 By integrating these sustainable materials and practices, the Chhattisgarh Pavilion can serve as a model of environmental responsibility and innovation, aligning with the broader goals of "Ek Bharat, Shreshtra Bharat."
- 8.4 The concept and professional approach of the bidders in their own concept design to make Chhattisgarh Pavilion attractive. The ambiance of the pavilion should reflect the flair and stature required in any international fair.
- 8.5 Cost offered to execute the work and detailed breakup of the cost must be given in the offer. As per the enclosed format.
- 8.6 Confidence and knowledge about the execution of work required for supervising and executing the

work.

- 8.7 Firm profile indicating total number of supervisors, bidders, engineers, and designers engaged with the firm and their experience in the field of doing such work and achievements made by them.
- 8.8 Infrastructure facilities available with the firm.
- 8.9 Knowledge about latest material used in similar interior works.
- 8.10 Evaluation of the bids would be based on concept, presentation and cost offered. 80% are assigned for concept and presentation; and 20% are assigned to cost offered. The bidder who scores more than 65 marks in technical evaluation will qualify for opening financial bids. The bidder who secures combined highest marks would be awarded the work.
- 8.11 The evaluation would be done on Quality cum Cost-Based Selection (QCBS) Evaluation based on the cost committed by the bidder and the technical qualification of the bidder.

9.0 SUBMISSION OF THE DOCUMENTS

All participants are required to furnish their professional profile in a separate cover along with tender document and concept design (in separate sealed covers, mention on top the contents therein). A detailed list of bidder's teams exclusively engaged for Chhattisgarh Pavilion must be submitted before the start of work.

(The list must have all the details like name, designation, Email ID, mobile and landline numbers of each member deputed exclusively for Chhattisgarh Pavilion).

10.0 IMPORTANT DATES

The work would be awarded to the selected bidder after execution of agreement, cost of which would be borne by the bidder. The basic construction works are required to be completed up to 10th of November 2025 so that complete display could be done on or before 11th November 2025 and pavilion must be ready in all respects before i.e., 12th Nov 2025. The site is likely to be handed over to the bidder in the first week of November 2025 as per norms of ITPO. There shall be no claim admissible in case of delayed possession of the site given to CSIDC by ITPO.

11.0 BRIEF ABOUT STRUCTURE AND BOARD REQUIREMENT

- 11.1 Chhattisgarh has been allotted Stall No. 2F-04 with a gross area of 775 Sq. Mtr (31Mtr x 25Mtr, layout provided in Annexure-IV) on the first floor of Hall No. 2, at Bharat Mandapam, New Delhi. Passage for free movement of public as per ITPO norms shall be provided inside the pavilion. Bidders are requested to study the layout carefully and propose their own ideas.
- 11.2 Stalls must be complete in all respects, including electrical fittings etc., and are to be constructed as per approved layout and design of every component.
- 11.3 Other items, like flowerpots, air conditioners, exhaust fans, pedestal fans, emergency lights, dry cell torches, fire extinguishers etc. are to be taken on a hire basis for the duration of the fair.

- Sufficient measures against safety, power breakdown and fire must be ensured for the duration of fair. The cost of such items on hire basis should be included in turnkey offer.
- 11.4 Provision for audio-visual presentation should also be kept in the stall. The audio visuals equipment's (like, Huge LED Video Wall, Desktop Computer etc. complete) and their arrangements should be included in turnkey offer. However, the material required for data presentations such as films, slides, CDs etc. would be provided by CSIDC.
- 11.5 Provision of CCTV surveillance should also be kept in the pavilion. The Pavilion should have its own surveillance room.
- 11.6 Two types of areas are to be developed within the pavilion, i.e., display area and sales area. In the display area, various exhibits of participating industrial units, Govt. Departments etc. would be displayed and in the sales area handloom and handicrafts of the state would be put to sale.
- 11.7 Entrance should reflect the theme of IITF 2025 "Ek Bharat, Shreshtra Bharat". The entrance of Chhattisgarh Pavilion must have (Compulsory) digital media along with 2D artistic work with clay murals and motifs. No flex prints will be accepted on the gate. Branding with embossed 3D Acrylic letters is must on the gate. A thematic display must also be created within the pavilion.
- 11.8 The entire branding in the pavilion should be only in digital print fabric/canvas media through UV printer.
- Other than display & sales area following top-covered built-up spaces with complete wooden laminate flooring are also required to be put up: -
 - (i) Closed VIP lounge
 - (ii) Store cum dry pantry area
- 11.10 Entire floor area of the pavilion should be raised with 4" wooden platform and the same should be covered with laminated flooring. The cost of such items should be included in turnkey offer.
- 11.11 Fascia of Chhattisgarh Pavilion and signage work within & outside of Chhattisgarh Pavilion should be designed according to the theme and it should be a part of turn-key offer.
- 11.12 The provision for working lunch for 20 people on daily basis must be kept in the pavilion for the officials and staff on duty from CSIDC. The cost of such items should be included in the turnkey offer.
- 11.13 The provision for also electric water dispenser, microwave, refrigerator, tea/ coffee/lemon tea vending machine should be made available at the pavilion on hire basis along with eatable and consumable, for the entire fair period. The cost of such items should be included in turnkey offer.
- 11.14 Floral decoration (Natural Fresh Flowers Only) of entire pavilion on inauguration day or any one other day stipulated by CSIDC, and the state day shall be done in Chhattisgarh Pavilion as directed by CSIDC. Six flower hand bouquets and four table bouquets shall be provided daily during the fair period i.e., 14-27 Nov 2025. The cost of same shall be included in turnkey offer.
- 11.15 The financial offer should be inclusive of arranging 4 female and 2 male guides inclusive of two premium and attractive sets of uniform (sarees) for entire period of fair i.e., 14-27 Nov 2025. The cost shall be included in turnkey offer.
- 11.16 The visual blow ups, write ups, bromides, and digital panels, translite collage including graphic designing etc. for theme and stall will have to be developed and prepared by the bidder.
- 11.17 Bidder will depute a representative in Raipur (Chhattisgarh) for collection/selection of base material like photographs & latest data from various departments of state government, as per the concept design and theme. The cost of same should be part of the Turnkey Offer.

- 11.18 The unit rate of graphic designing, duratrans prints, canvas/fabric printing with frames, ink jet digital printing with mounting and lamination, translites prints and other display media must be quoted separately along with quantities as per the design submitted in enclosed format.
- 11.19 Entire pavilion including display exhibits is to be insured for an equal amount quoted in financial bid from any nationalized insurance company and the cost incurred in getting the pavilion insured would be borne by the bidder.
- 11.20 It will be the sole responsibility of the bidder to seek approval of the layout plan and proposed work of the pavilion from the ITPO. The fee for the same to be paid to ITPO would be paid by the bidder. It will also be the sole responsibility of the bidder to seek approval of the layout plan of Pavilion from Chief Fire Officer, Delhi Fire Services, Connaught Place, New Delhi.
- 11.21 The Fire Protection measures are of paramount importance, and it will be the sole responsibility of the bidder to make all necessary arrangements to ensure public safety for which fire prevention and security measures are to be adopted as per the National Building Code of India and norms fixed by ITPO.
- 11.22 Unserviceable materials, not required for the execution of work, will have to be removed from the site by the bidder well in time. The cost shall be included in turnkey offer.

This new Industrial Development Policy 2024-30 offers unmatched incentives to accelerate industrialization and position the State as a leading hub for investment. Highlight policy special packages
- 12.6 Services sector which is now included in Chhattisgarh Industrial Development Policy 2024-30
- 12.7 Chhattisgarh's vision for Industry in 2047 is to become a leader in manufacturing excellence, driving innovation and value addition, empowering Micro-Small and Medium-sized Enterprises (MSMEs), fostering global trade, and championing green manufacturing, with a focus on four key vision elements such as value addition of natural resources, create a world class ecosystem,

- 6. The Party No.2 shall be responsible for proper upkeep and maintenance of the pavilion and various services throughout the fair period, and during the extended period if any, by whatever name and style with or without break including the repairs and maintenance and replacement as may be necessary for proper exhibition and display.
- 7. The Party No.2 shall also be responsible for clearance of site after completion of work as well as after the end of the fair as per the norms of ITPO.

- 8. The Party No.2 shall, also do all subsidiary works connected with the principal work as ordered by the Party No. 1 or his authorized representative. No material, service, electricity, water, tools, plants, and equipment shall be provided by the Party No.1 for the purpose of execution of the work under this contract.
- 9. All items including material of construction shall be subject to the inspection prior to utilization. This inspection shall be done by the Party No.1 or his authorized representative and in case of rejection of any item or unit; the same shall not be utilized by the Party No.2. The Party No.2 shall also abide by all orders, instruction, rules and regulation or laws of the Government or any local authority or ITPO and in case of violation or contravention the Party No.2 shall alone be responsible including compensation payable to Party No.1.
- 12. The Party No.2 shall not be entitled to any compensation from the Party No.1 of whatsoever nature, on account of any delay caused from the side of the Party No.1 either delay in handing over the site by ITPO, or due to change of design or drawing or for any other reasons or circumstances.
- 13. The Party No.2 shall make his own arrangement for watchmen to guard the materials brought by him and those supplied by the Party No.1 under this contract and shall ensure the safety from breakage and to the materials fixed/ unfixed by him or his sub-Bidders for the entire fair period.
- 14. All works to be executed under contract shall be executed under the direction and subject to the approval in all respects of the Party No.1 or his authorized representative, who shall be entitled to direct at what point or points and in what manner these works are to be commenced and from time to time carried on.

- 23. Any dues that remain to be recovered from the Party No.2 shall be recoverable as arrears of Land Revenue under relevant Acts of competent Jurisdiction.
- 24. That the Party No.2 shall keep informed the Party No. 1 or his authorized representative on day to day progress of the work and in case the work is not in progress of the work and in case the work is not in progress to the satisfaction of the Party No.1 It shall give written warning to the Party No.2 which in turn shall comply and abide by the instruction and orders in this behalf, on this violation, the work will be completed and done by the Party No.1 at the cost of Party No.2 and all the loss, damage and compensation shall be recoverable from Party No.2. Similarly in case of any failure of the work as contemplated the work shall be done by the Party No.1 at the cost of the Party No.2 and the compensation shall be recoverable from the Party No.2 as stated above.

- 25. All disputes relating to the specification, design, drawing, sketches, quality, and workmanship shall be decided by the Managing Director, CSIDC and his decision shall be final and binding on both the parties.
- 26. SUBLETING: The Bidder shall not, without the prior approval of the competent authority in writing, sublet or assign to any other party, or parties the whole or any portion of the work under the contract. Even where such approval is granted, the Bidder shall not be relieved of any obligation or duty or responsibility which he undertakes under the contract.
- 27. REMOVAL OF UNDESIRED PERSONS: The Bidder shall, on receipt of the requisition from the Party No. 1 or his authorized representative at once remove any person employed by him on the work, who in the opinion of the Party No.1 or his authorized representative is unsuitable/undesirable.
- 28. The Party No.2 undertakes to complete the work within the stipulated time and in case of any delay he/she/it shall be liable to compensate to Party No.1 @ 50,000/- Rs (Fifty Thousand Only) per day apart from any other compensation recoverable on account of loss of reputation or monetary loss or any other loss.
- 29. All disputes of difference whatsoever arising between the parties out of or relating to the constitution, meaning and operation or effect of this agreement or the breach thereof shall be referred for arbitration to the Managing Director, CSIDC, Raipur and his own decision shall be final and binding on both the parties. The venue of arbitration shall be Raipur (C.G).
- 30. All suits and legal proceedings under this agreement will be subject to the jurisdiction of court at Raipur only.
- 31. The Party No.2 shall also have insurance of pavilion for an equal amount of his financial bid before issue of advance/1st running bill, failing which insurance would be done by department at the cost of the Bidder.
- 32. The royalty charges for the materials shall be borne by the Bidder.
- 33. Cement, steel, or other building materials if required to be used in work shall have to be arranged by the Bidder.
- 34. The Bidder is required to put up his rate for the following maintenance staff (Compulsory) exclusive for Chhattisgarh Pavilion during the complete fair period. The maintenance staff should have a common uniform provided by the bidder, cost of which will be part of price quoted. Details of exclusive staff: -

d. Exclusive Supervisor for Chhattisgarh Pavilion : 01 Nos.
e. Electrician cum Carpenter for Chhattisgarh Pavilion : 01 Nos.
f. Sweeper for Chhattisgarh Pavilion : 02 Nos.
g. Helper/ Labour for Chhattisgarh Pavilion : 02 Nos.
h. Security Guards (In day shift) : 04 Nos.

35. The staff shall be equipped with all tools necessary for repair and maintenance. The helpers shall have sufficient sets of dusting cloth, mops, brooms, buckets, soap, detergent etc. complete.

- 36. The Party No.2 shall also provide sufficient laborers and skilled workers required for loading/ unloading, stacking, storing, and display materials, at any floor, at any levels as per instruction of the Party No.1. In the event of failing to do so, the Party No.1 shall carry out the above at the cost of the Bidder.
- 37. Apart from income tax, taxes, if any imposed by State/Central Government and local taxes will also be recovered from the Bills.
- 38. If at any time after execution of the contract, the Party No. 1, or his authorized representative is of the opinion for any reason that any part of the work or items of work or class of work specified in the contract do not require to be carried out at all, shall bring to notice in writing of the fact to the Party No.2 who shall then stop the work and shall not be entitled to the amount specified against the said item or items.

 Similarly, the Party No.1 shall be entitled to make necessary changes, amendments, addition or

Similarly, the Party No.1 shall be entitled to make necessary changes, amendments, addition or alteration in drawing, specification, sketch plans and the same shall be duly carried out and complied with by the Party No.2 as if they were the part of the original contract and no additional payments shall be made to the Party No.2 for such work. The Party No.2 shall not be entitled to claim any cost, profit, or any compensation on account of either dropping of the work or any item.

- 39. If at any time after execution of the contract, the Party No.1 or his authorized representative is of the opinion for any reason that any part of the pavilion is to be covered by star flex, or any other media has to be carried out without any additional payment.
- 40. If additional items executed on demand of the Party No.1 (which is mandatory to be executed) other than agreement in course of execution it will be paid based on rate analysis of the additional item.
- 41. The work must be executed as per norms of lump-sum tender for the works covered under scope of turn-key offer or revision thereof Payment would be made based on proportionate progress, made in form of running advance. Final evaluation of cost of executed works shall be based on timely completion, quality of input materials, workmanship, aesthetics, and appearance.
- 42. The bidder after the execution of the turnkey agreement shall not make himself eligible for the payment of the entire amount of contract unless each item is executed quantitatively and qualitatively as per agreed scope of work under the contract.


