4. **Pre-Qualification Criteria** -To be eligible under the contract, the intending tenderer should meet the following mandatory criteria **4.1 (A & B) and 4.2 (A, B, C & D)**

4.1 Financial Criteria

- A. Average Annual Turnover:** Minimum average annual gross turnover of the bidder shall be **INR 6.78 Crs.** during last three complete financial years out of FY (2021-22, 2022-23, 2023-24 & 2024-25). (Audited balance sheet duly signed by CA and duly notarized should be enclosed). Annual turnover is total certified payments received for contracts in progress or completed during the financial year. **For above, the Tenderer has to submit audited balance sheets of their financial turn over/accounts along with profit and loss account for the last three or four years, along with the Tender. Where necessary, the Employer can make enquiries with the Tenderer’s Bankers.**
- B.** The tenderer should be a profit(net) making firm and should not have incurred any loss in the last 2(two) financial years and have not incurred losses for more than two financial years out of last five financial years ending 31st March, 2025 duly certified by Chartered Accountant. Net worth should be minimum 20% of PAC in any one financial year out of last two financial years ending 31st March, 2025 duly certified by Chartered Accountant.

4.2 Technical Criteria

Note: -

- a) *For the above purpose, value of executed works (for similar work & key activities experience) and financial turnover shall be brought to current costing level by enhancing the actual value of work at the rate of 10% per annum (compounded annually), calculated from the date of completion to last date of receipt of applications for E-Tenders.*
- b) *Ongoing project / part project experience shall not be considered for evaluation. Only experience as prime contractor in the same name and style shall be considered for evaluation.*
- c) *For the benefit of the intending tenderers a checklist is enclosed at Schedule-D-Section-I, for the documents to be submitted along with tender. Tenderers are required to submit other documents/information also with the technical tender as required in the detailed NIT or elsewhere in the Tender Document PART ONE, otherwise it shall lead to rejection of bids.*
- d) *Successful bidder shall have to employ sub vendor who has experience in execution of that component, for which tenderer does not have experience. The sub vendor shall be got approved from CSIDC before start of concern activities.*
- e) *The bidder must have experience of successful completion of atleast any one construction project work within the time limit specified in the agreement or within the extended time period without any penalty in last 7 years.*

 - b) The tenderers shall also submit satisfactory completion certificates in support of each quoted experience along with work order. The satisfactory completion certificate should be signed by an officer not below the rank of Executive Engineer concerned in case of Government department or the rank of General Manager in case of public sector as the case may be.
 - c) **All the documents to be submitted shall be duly notarized.**
